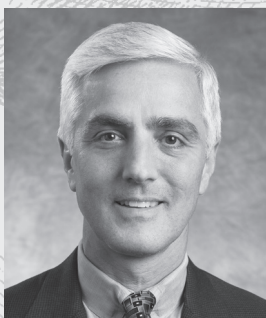

Sarah Abshier, DPM – Seminar Chair

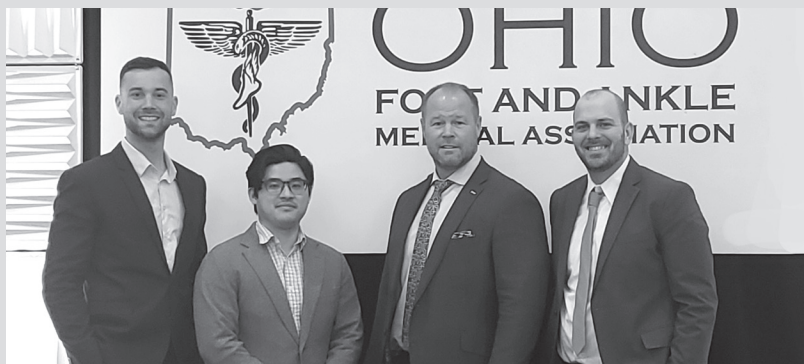
