### From The Desk of the Executive Director When The Big Rocks Morph Into Boulders

mental tasks. Beginning the third quarter exacerbates the urgency: getting CME, SGR cuts, DME, PECOS, PHI, HITECH, PCI – credit card protection of data, and now MITS – coming December 7 for Medicaid reimbursements. As physicians, it's impossible to be non-reactive.

### Paperless Provider Enrollment Going Live

In December 2010, paperless provider enrollment features will be available in the New Information Technology System (MITS) and MITS Go-Live Web Portal!

### MITS Provider Enrollment Features

Provider Enrollment is the MITS business function that will offer online enrollment and update capabilities for all providers interested in becoming an Ohio Medicaid provider. The new MITS Web Portal Provider Enrollment features include:

- Submission of new Provider Enrollment applications via the MITS Web Portal. Providers are guided through this process by a Provider Enrollment wizard;
- The option for providers to attach documents through the MITS Web Portal required to verify certification and licensure;
- Allows providers to check the status of a new application by using an Application Tracking Number (ATN) assigned to the application. The ATN serves as a receipt of the application submission;
- Providers can complete the application at a later time if the process is interrupted, and allows

### **Online Enrollment Safeguards**

To ensure the Provide Enrollment application is accurate and complete the Web Portal functionality will:

- Check for duplicate enrollment applications and status;
- Screen required data (NPIs, Tax IDs, and CLIA numbers);
- Verify provider status with internal and external entities; and
- Facilitate and increase efficiency of the Provider Enrollment application process.

The online application process will also include the enrollment of other entities that do business with Medicaid such as trading partners and sub-recipient state agency providers.

up to three days to make updates prior to submission;

- Providers can validate their information and keep information up-todate; and
- Generate reminder notices 120 days prior to the re-enrollment date.

#### **Good-bye Paper**

Paper applications will *not* be accepted after MITS Go-Live. New applicant provider enrollment will only be available via the MITS Web Portal.

#### MITS Web Portal Provider Data Maintenance Business Function

The Provider Data Maintenance business function maintains comprehensive, current and historical information about providers who are eligible to participate in the Ohio Medicaid program. This function of the new MITS Web Portal will:

- Encourage the participation of qualified providers, making enrollment and re-enrollment efficient, and accurate;
- Help ensure that pro-

viders are qualified by screening for state licensure, certification, and specialty and sub-specialty certification;

- Provide for processing of provider contracts and changes in a timely, accurate manner;
- Maintain control over all provider data;
- Establish and maintain a provider repository with:
   ~ demographic informa
  - tion;
    ~ certification and licensure information;
  - ~ reimbursement rates;
  - ~ summary of financial information; and
- Maintain functions to support provider training activities.

Providers will be able to:

- Receive and acknowledge alerts and notices within Global Message viewer;
- Search for all provider alerts regardless of the intended audience. For example, an optician can view all messages sent to optometrists;
- Use the Demographic Maintenance to verify address, phone numbers, and other information


related to billing; and

 View/download reference extract files, such as fee schedules, Provider handbooks, FAQs, forms, and other publications.

Provider Data Maintenance and the entire new MITS system will meet the requirements of the National Provider Identification (NPI) standards of the Health Insurance Portability and Accountability Act (HIPAA).

### What About Training?

An extensive statewide outreach and training strategy is in development, with training to begin this fall. Watch for the most current news on the MITS Web site, http://jfs.ohio.gov/ mits/communication.stm, about training and registration, and make plans for you and your staff to attend a seminar or webinar. ### REPORT FROM THE STATEHOUSE Creating The Best of Both Worlds

2010 is an active political year and with it comes limited days of legislative work at the Statehouse. This is not necessarily a negative fact if you are working to stop bad legislation. If you are working to pass good legislation, it can be frustrating. For the Ohio Podiatric Medical Association and our priority issues at the Statehouse, we have a little of both.

Looking at Ohio's political landscape, the May primary did not produce any significant upsets. The election simply lays the groundwork for a contentious battle for the Governor's office as former Congressman John Kasich (Republican) challenges incumbent Governor Ted Strickland (Democrat). Both political parties will also be focused on victories in the Auditor's office and Secretary of State's office, two critical positions that

play roles in redrawing district lines that determine legislative districts for the next ten years. Additionally, a number of races for seats in the Ohio House will also be closely watched as Republicans look to shift the 53-46 Democrat majority makeup of this important chamber.

Statehouse halls are quiet over summer months as legislators refocus priorities on working in their district and preparing for general elections. Legislators are not expected to return for full legislative activity until after the November 2nd elections.

#### **Statehouse Shuffling**

Two new legislators recently took seats in the Ohio House. Joe Walter, Director of the Lucas County Emergency Management Agency, was elected to fill a vacancy created by Representative Peter Ujvagi. Cynthia Reece, formerly Cincinnati Vice Mayor and a Cincinnati City Councilman, recently replaced Representative Tyrone Yates, who was ap-

pointed to Ham-

ilton County Municipal Court. Additionally, a number of House Committees were shuffled to address the restructuring. Rep. Tim DeGeeter now chairs the Criminal Justice Committee. Rep. Alan Sayre replaces Rep. DeGeeter as chair of the Public Utilities Committee. Rep. Tracy Heard has been appointed chair of the Public Safety & Homeland Security Committee, and Rep. Linda Bolon has been appointed chair of the **Finance Transportation** Subcommittee.

#### Update on Legislation of Interest

HB 81 (Boyd/Gardner) Diabetes coverage bill: Legislation to cover the cost equipment, supplies and treatment of diabetes remains stalled in the Ohio Senate. The bill passed the Ohio House of Representatives in December 2009, but Senate Leadership has said insurance mandate bills are low priority.

HB 185 (Book/De-Geeter) Prohibiting unilateral contract changes: Hearings have also stalled in the Ohio Senate on HB 185, legislation sponsored by Reps. Todd Book and Tim DeGeeter to clarify that any change to a contract between a health insurance company and a provider is signed off by both parties. As the insurance lobby has stepped up their opposition, it is clearer that the bill will be a hard sell in the Ohio Senate. HB 185 had opponent testimony on February 9, 2010, and has not had a hearing since.

HB 122 (Boyd)/SB 98 (Patton) Physician designation bill: The Academy of Medicine of Cleveland and Northern Ohio and the Ohio State Medical Association are working to set standards for physician rating systems established by health insurance companies. The OPMA was suc-

cessful in advocating that the definition of *physician* in the bill also include *podiatric physicians*. The bill prohibits such systems from being based solely on cost measures. HB 122 was voted out of House in February 2010; SB 98 had a number of hearings. Both are pending a vote in the Senate Insurance Committee.

HB 267 Official Prescription Drug Program, Introduced in House: Rep. Clayton Luckie (D-Dayton) continues to advance his bill to create a mandatory prescription pad program in Ohio. The bill requires all prescribers in Ohio to purchase tamper-resistant pads from the Ohio Board of Pharmacy. Prescribers who lose or have pads stolen would be required to report that information to the board. The board would then alert pharmacies of the missing prescriptions in an effort to reduce fraud. In a compromise effort, Rep. Luckie proposed reducing the pads' annual fee from \$250 to \$100. Although HB 267 has not had a hearing for months, Rep. Luckie continues to talk to interested parties about his ideas. The OPMA will participate in these discussions and express our concerns about this proposal.

#### HB 442, Complementary and Alternative

**Medicine:** Rep. Kenny Yuko (D-Euclid) has introduced a "perennial favorite" bill in the legislature to allow for the unregulated practice of alternative and complementary medicine. The OPMA testified in opposition to this bill in May, sharing our concerns that unregulated medicine can pose significant risks to patient safety and that the state needs to ensure alternative providers have appropriate training and oversight as they take the health and safety of Ohioans into their hands.

HB 442 is being heard in the House Commerce and Labor Committee that is chaired by the bill sponsor Rep. Yuko. We anticipate that Chairman Yuko will continue to push the bill during the lame duck session this fall.

SB 86 (Buehrer) Expanded qualified immunity for ER Physicians: SB 86, a bill to expand qualified immunity for physicians working in emergency departments and those who provide disaster relief services passed the Ohio Senate on May 19. The bill included a compromise to change the legal standard for physicians in emergency rooms to a slightly lesser standard of "reckless disregard." The higher standard of "willful and wanton disregard" stands for health care providers providing disaster relief services.

The OPMA was also successful in convincing the sponsor and committee chair of this bill to include *podiatrists* in the definition of eligible providers. SB 86 now heads to the House for further consideration. It has been referred to the House Civil and Commercial Law Committee.

### Ohio's Budget Crisis Impacts Providers

Challenges for podiatry are greater than ever in recent history. National health reform, electronic health records, third-party payers, state and federal deficits, SGR, Title XIX and residency shortages are areas where the best of podiatric leadership will be needed. Leadership can only be successful with substantial support from the "rank and file" podiatric physicians. For example, let's illustrate how the budget crisis in Ohio's state government impacts Ohio podiatrists:

- The state budget must be balanced per the Constitution. With a budget of over \$50 billion, a projected \$8 billion hole was filled using on-time federal stimulus money.
- Ohio's unemployment compensation fund is bankrupt. Ohio owes the federal government \$4 billion that comes due, including interest payments, beginning in 2011.
- All five Ohio public pension funds are underfunded. Ohio taxpayers will be tapped to restore these funds.
- State elected officials have made commitments to public educa-

tion (K-12); add \$3-4 billion.

 Medicaid costs continue to rise. With HC Reform, 554,000 will be added to the ODJFS rolls and this will cost Ohioans \$1.45 billion.

The impact is uncertain. That's the reason OPMA remains always vigilant and proactive, calling for the support of *every* podiatric physician in Ohio. OPPAC contributions, paying dues to OPMA on time and supporting the OPMA Legal Fund are a few ways OPMA members provide support.

### CONTINUING ED NEWS Continuing Medical Education Credits: Approval Policy for Ohio Credit

Many organizations and members submit continuing medical education programs to OPMA for podiatricspecific continuing medical education credits for approval by the State of Ohio.

As you know, the State Medical Board of Ohio approves all CME certified by the OPMA (Section 4731.281). Accordingly, the process for CME approval begins with OPMA.

OPMA's web site contains all the information needed for submission for course approval. (*Please note these changes have nothing to do with CPME [nationally recognized podiatric credit].*) Only CME programs for Ohio credit are affected.

We are writing to inform you of changes that will occur on *July 1, 2010.* 

### The Updated Ohio CME Policy

On April 22, 2010, the Board of Trustees qualified the staff time spent on processing the many CME applications OPMA receives. The motion advanced by the Budget and Finance Committee for consideration was adopted by the Board of Trustees as OPMA policy.

The newly adopted OPMA policy establishes the fee schedule for CME approval (Effective July 1, 2010.) See inset:


The OPMA web site will continue to post all approved CME programs or courses for member audits for reference purposes. All programs submitted and CPME or Ohio CME approved course programs) will not be posted, but the attendee requesting the credit will be notified after the program/meeting brochure is reviewed by our CME Chair. (i.e., going to Texas to attend a Hyperbaric Oxygen lecture program for physicians at a hospital). We can approve those programs pre- or post-; however, the cost increases after a 30-day period. The brochure or a copy must accompany your request for program

important for all events that would involve *out-of-state participants* and would give recognized accepted credit in any state for events approved by OPMA. If you hold a license in another state, CPME approved programs are accepted outside the state of Ohio.

#### Texas Podiatric Medical Association Denied Review by Texas Supreme Court

We regret to report that Texas Podiatric Medical Association (TPMA) got a denial from the Texas Supreme Court to grant our Petition for Review on June 18. The effect of this adverse action:

a. The Rule defining "foot" remains in place and the scope stays the same until all remedies are exhausted at the Supreme Court.

b. TPMA will immediately

file the Motion for Rehearing with the Supreme Court. That could take from 60 days to 6 months.

c. The Motion for Rehearing should stay any actions by hospitals pending the final outcome of the Supreme Court, but in the meantime TPMA will respond with assistance and support as may be appropriate for members who may get questions or modifications of privileges from their hospitals.

Unless TPMA gets the rehearing, TX podiatrists may be limited to "at or below the ankle" and probably will lose "above the ankle" privileges that they have had for several years (unless they can get regulatory or legislative intervention). This battle has been ongoing for the past ten years.

### Senate Passes Six-Month SGR Fix

The U.S. Senate passed an amended version of H.R. 3962, now called the "Preservation of Access to Care for Medicare Beneficiaries and Pension Relief Act of 2010," by unanimous consent. This legislation provides a 2.2 percent Medicare physician payment update for six months, from June 1 through November 30, in lieu of the 21 percent cut scheduled for 2010.

Once H.R. 3962 is passed by the House and signed by President Obama, CMS will retroactively adjust any June claims that have been paid.
